The Colchester Housing Authority met on November 17, 2016 for its monthly business meeting at Dublin Village. The meeting was called to order at 7:03 PM.

The Secretary's minutes for October were reviewed; a motion was made by Lou and seconded by Denise to accept the minutes as submitted.

A motion was made by Marion and seconded by Lou to accept the Financial Report as submitted by the Executive Director; the motion passed unanimously.

ADDITIONS TO THE AGENDA-none

COMMUNICATIONS

-10.24 The pre-bid meeting for the SCBG was held in the Dublin Village community ... room. Eleven contractors attended and took the tour.

-11.3 CT Water finished replacing water shut offs in the pump house and the mains in the residential buildings at Ponemah.

-11.7 The asbestos levels in older units to be rehabbed at Dublin are .002 ppm above the limit and thus abatement will be required. Residents will need to leave their unit during demolition and may not re enter until air quality testing is approved.

Newer units constructed in 1993 were tested and found to be asbestos free.

-11.7 The State DOH received the pre-development loan agreement we prepared at our last meeting.....cricket-cricket.....crickey-cricket...

-11.10 Bid opening was held at Town Hall. Art Shilosky, Trica Dean, Chris O'Neill, Lou Delpivo, Rob Gustafson and three contractors attended. Bids were opened and recorded. The lowest qualified bid was \$2,920 over the budgeted amount of \$686,580 of the awarded \$800,000.

-11.14 Spoke with Nancy Wagner about the overage and options for reducing costs. Some ideas include switching the lav countertop to laminate, deleting new landscape plantings.

-11.15 Spoke with Eversource about reducing community room rate from commercial to residential. It sounds likely they will do so.
