7. **OLD BUSINESS**

A. "School for Colored Children" - Building replacement and 3rd Grade Walk -For discussion and possible motion

Chairman Sharon said that Carefree Sheds has offered to remove and replace the existing building. The Town Public Works Department will do the site work. Arthur Liverant and his family has offer to construct a new building.

Arthur Liverant, Colchester resident, gave a brief history of the "School for Colored Children" and presented pictures of an existing school in Hebron. He said that the building would be about 26' wide and 18' deep. The materials used would be clapboard, wood for the roof and stone, brick or granite for the foundation. He feels it would be a true replica of the original school. He would like to include desks and long benches and a simple chalkboard in the interior. This would be a gift to the Town from the Liverant family. Discussion followed regarding the construction of the building and the proper procedures to follow as far as obtaining the necessary permits. The Commission expressed their appreciation to Mr. Liverant. Chairman Sharon said that a thank you letter to Carefree Sheds should be written expressing gratitude for their offer.

Chairman Sharon said that she has not received the finalized schedule for the 3rd Grade Walk, but it is scheduled for the latter part of May and the first part of June. Once the dates are received, a schedule of volunteers will be needed. She said the members of the Historical Society have also volunteered to help.
