Programs

Fall Program registration has started and online registration is going well. See Supervisors Report.

Activenet

The new software has been a time consuming project yet it has been fully implemented for Fall. A large percentage of data has been transferred from the new system. Participants can now sign up for FREE online! Fall registrations have been going extremely well online. The next phase is to have Endorsed Sport leagues enter their own reservation dates. Projected start date spring 2013.

Summer Concerts

Concerts ended extremely well on Thursday nights. Staff members stated that the crowds were larger than past years.

Summer Camp

Day Camp ended well with our final week (week 8) with 133 children. Kindercamp also ended well with 20 children on M-F and 10 on M/W/F. Staffing was at full levels for both programs.

Colchester Community Theater

The CCT had a great camp with 70 children in attendance.

The Dog Park Committee

Has a new interim president- Carol Small. They are actively looking for new members to run for positions.

57 Fest

Planning and marketing is underway. Sponsors, fireworks and food vendors are secured. Booths performers, volunteers, and some logistics are still being finalized. Overtime staffing costs are NOW being covered by the General Fund which will reduce the burden to the Program Fund. See attached budget.

Office Staffing

We are short staffed as our Administrative Assistant position is open. I am looking to make some changes to that position. Once finalized, we will begin posting to hire.

Program Fund

The funded ended better than in past years. Revenue for 2011-12 was \$302,212 (includes the \$40,000 subsidy) and expenses (\$312,658.88) so a negative balance of \$ (\$10,581.31) in the fund for 11-12. See attached.
