Petruzzi's proposal to change section 13.2 of the Rules and Regulations to reflect the correct firearms that the officers have been certified to use. SECONDED by Commissioner Nolan. All members present voted in favor, MOTION CARRIED.

b. Discussion and Possible Action on Creating a Change to the Rules and Regulations Sgt. Suchecki stated he was approached by the rank-and-file asking to add under section E of the Rules and Regulations neatly trimmed goatees as acceptable facial hair for the Colchester Police Department. Discussion was had. Commissioner Parlee asked Sgt. Suchecki to come up with the exact wording and the board will take it under review at the next Commission meeting.
