The meeting was called to order at 6:02.

Additions to Agenda: There were no additions to the agenda.

Approval of Minutes: Marge Mlodzinski moved and Andreas Bisbikos seconded the approval of the minutes of April 20, 2016.

Discussion and Possible Action on Talking Points for the Purchase of Senior Center (SRC) Building and Future New SRC: The group discussed the latest list of talking points. A few minor changes were suggested. Rosemary will update the current list and email them to the Subcommittee.

Discussion and Possible Action on Timeline and/or Steps for the Purchase of the SRC Building/Land and Moving Forward to New SRC: We have not set a Timeline as yet. The Town needs to approve the Board of Education budget before we can move forward in creating a definitive Timeline. Art noted that it is hoped that the Budget will go to Referendum by June 1, 2016.
