1. CALL MEETING TO ORDER.

Chairman Robinson called this meeting to order at 7:03 p.m. Alternate P. Hayn was seated as a voting member.

2. ADDITIONS TO AGENDA None

3. PUBLIC HEARINGS

Chairman Robinson reviewed the ground rules for the hearing and said this was a continuation of the Public Hearing of May 18, 2010.

A. ZBA#09-017, Bartolto Gallitto, Applicant/Owner, for property located at 289 Chestnut Hill Rd, Tax Map # 03-03, Lot #030-010, R-60 Zone. The parcel is located on the North side of the road, 1400' west of the intersection of Chestnut Hill Rd. and Ridgewood Dr. Applicant is requesting a variance to Section 13.21.2.1 of 7.0' to reduce the front yard setback to 43'. The variance is necessary to allow an already constructed porch to remain in place. (PH opened 5/18/10, continued to June 15, 2010)

The Public Hearing was opened at 7:04 p.m.

Chairman Robinson noted that the voting members for this application are: L. Robinson, P. Reading, B. Setschinsky and P. Hayn. M. Solis was not available this evening and A. Shilosky could not vote on this application as he was not present at the May 18, 2010 meeting.

C. Grimord recapped the Public Hearing from the May 18, 2010 meeting and reviewed 'the additional Exhibit items. He presented the aerial photos showing the distances between the houses located at 285 and 289 Chestnut Hill Road.

Chairman Robinson noted that B. Gallitto, applicant and owner, had not arrived at this time.

Jody Barr, 285 Chestnut Hill Road, asked questions regarding the structure of the porch and if it met current building codes. He also asked if Mr. Grimord had inquired about the year of the photo on the Assessor's card. Mr. Grimord answered that he had spoken with J. Chaponis, Tax Assessor and was told the picture was taken in 2005. Mr. Barr asked about the hardship on the application being that the porch needed to be handicap accessible. He also submitted 3 photos that were taken at the same time but showed three different electronic dates on them. He also questioned the use of the lumber purchased on the receipt listed as Exhibit Item "U" and the Building Official's determination of the lumber being weathered. He had submitted a letter from an appraiser regarding the effect of this porch on the value of his property and he asked the Board not to grant the variance.

Discussion followed regarding the determination of the age of the lumber and the §8-13a and 8-2 of the Connecticut General Statutes regarding non-conforming structures.

Chairman Robinson acknowledged that Mr. Gallitto, applicant/owner had arrived and asked if he had any further information to be submitted. Mr. Gallitto submitted a letter regarding the construction of the porch and his relationship with his neighbors the Barrs. P. Reading read this letter into the record.

Discussion followed about the use of building materials listed on the sales receipt, the handicap ramp and the date the construction began on this porch. B. Gallito stated that construction started in February of 2007 soon after the lumber was delivered.

Frank Gallitto, 289 Chestnut Hill Road, spoke about the pictures that were taken and the building materials used for the porch. He also noted the distance between the Gallitto property and the Barr property.
