**Department of Services & Infrastructure Annual Bids FY 2014 – Joint & Cracks Sealing Various Locations 2013**

The Director recommended that the Board accept the recommendation of staff to award the bid to the low bidder.

A motion was made by Mr. Branco and duly seconded by Mr. Azinheira to award the annual bid FY 2014 for Joint & Crack Sealing various locations 2013 to the low bidder, Sealcoating, Inc., of Braintree, MA. So voted.

**Water Pollution Control Annual Bid Award FY 2014 – Toxicity Testing and Chemical Analysis**

Mr. Hickox recommended that the Board accept the recommendation of staff.

A motion was made by Mr. Azinheira and duly seconded by Mr. Branco to award the annual bid award FY 2014 for Toxicity Testing and Chemical Analysis to EnviroSystems, Inc., of Hampton, NH. So voted.

**Contract Award – Reed Road Water Main Construction Project**

Mr. Hickox reminded the Board that the project had been rebid.

A motion was made by Mr. Branco and duly seconded by Mr. Azinheira to award the bid for the Reed Road Water Main Construction Project to the low bidder, Susi & DiMascio Co., Inc., of Hyde Park, MA, for the amount of \$375,908. So voted.

**Water Division Bid FY 2014 – Filter Media Replacement**
