Motion made by Wayne Whalley, seconded by Elaine Lancaster, and unanimously voted to approve the Council on Aging Minutes of January 28, 2013.

All persons interview to fill positions will have to have a physical. After being hired, a drug test is required.

Ms. Raymond reported that windows were broken in one van and the catalytic converter was stolen from another. One seat was taken out of a van to make it lighter and now can get a sticker for it. There was a leak in a van above the drivers head and she requested that the people who made it should be obligated to pay for the repair.

Beverly who has been the Shine person will no longer be able to be at the center since she is moving out of state.
