- After a motion was made by Jennifer Brindisi and seconded by Richard Golen, it was voted (3-0, with 1 abstention-Jacquelyn McDonald) to approve a Standard Order of Conditions for a Notice of Intent from Tekeyla Atkinson re: Map 177 Lot 16 on 11 Tolland Path, Dartmouth, MA. File 15-2218.

- South side pavement will be left alone.
- Reinvigorate storm water discharge points.
- Some regarding will be done.

 - Steve Gioiosa was present to speak in regards to the Rifle Range.
 - Trails have been added.
 - Restoration work has started.
 - Woodchips will be used to stabilize the outer area.
 - Hay bale lines will be added to help prevent erosion of the pathways during the stabilization process.

 - The buffer zone will be entirely restored.
 - The shed is exempt even though it is partly in the buffer zone.
 - The Commission would like periodic reporting on remaining restoration.
