6:35PM Reserve Fund Transfer Requests

Ed Icaponi – General Government - 2 Day Assessment for Police Department - 86 Applicants for Deputy Chief position. The assessments are administered to the top six candidates selected. The funds also cover the cost of advertisement and posting of the position.

Motion to approve Reserve Fund made by David Ferreira 2nd Mary Louise Pass 7-0-0

Police Chief Mark Pacheco - Police Department - Discussion of accident involving a 2008 police cruiser. Insurance adjuster claims total loss of the vehicle. Officer was chasing suspect. Conditions of roads were slick resulting in an un-avoidable crash of the vehicle. Officer was not harmed. Chief states this is an experienced officer who feels badly about this incident. Equipment within vehicle is salvageable.

Mary Louise followed up with a more details around the insurance claim.

6:40 2009 & 2010 Revenue Update - Ed Icaponi

Reviewed Financial Analysis Appropriation and balance review sheets. Ed provided details regarding the departmental turn-backs resulting in approx \$3.8MM in funds which Ed will work to certify with the state.

Patrick asked for clarification of the under/over account of the Assessment Reserves.

2010 Analysis - Ed Since we were \$190K less in Chap 70 funding from the state we will need to insure the schools are set to the minimum net school spending threshold.

Ed - We will need to look to reconcile the TM articles of meals and room tax approx \$500K

7:00PM - Budget Discussion - Ed Icaponi - Ed stressed this is a draft version of the fiscal 2010 budget.

7:05PM - Peter \$3.8MM w/ some offsets but we should begin to think about how to appropriate funds, such as much needed capital improvements and set a policy and strategy in place relative to the meals and room tax increases.

STAB FUND - How do we best adhere to policy to grown the STAB FUND to 10% of our operating budget within our 5 year goal.

CIP FUND – Peter asked members to begin strategizing on how we want to address the various CIP needs of each department.

David - The policy on STAB FUND - our policy obligation is to STAB FUND \$1.1MM per year based on last years 5 year projection is the goal.

Example Strategy discussed by FinCom - hold on \$500K in 1 time revenue from the meals and room tax. And meet the remaining amount turn-back funds. With the goal of \$1MM -

Peter - turn-back with accounting for State Reserve would leave approximately \$1.9MM for CIP appropriations. FinCom then discussed the prioritization of the CIP requests within the 5 year plan.

7:50 Greg - 1 Time Revenue Discussion - related to operating expenses - A discussion among FinCom members about our policy that we do not use 1 time revenues as a way to fund operating expenses.
