INTRODUCTION OF NEW MEMBERS

REVENUE UPDATE FOR FY09

Good shape as far as expenditures, will turn back ~200K from police, more savings from health care (~700K), unemployment will have turnbacks (~100K). Should have close to 500K from reserve fund. Should have fairly substantial total turnbacks.

RESERVE FUND TRANSFERS

- Town Hall: \$2800.00 Need to replace air conditioning unit. Ferreira moves, Lantz seconds (7-0-1)
- Legal: \$35,000 Lantz moves, Nunes seconds (8-0-0)
- Legal COA: \$7,000 Ferreira moves, Jenkins seconds (8-0-0)
- COA: \$11,242.46 COA received grant to purchase new van which requires 20% matching. Ferreira moves, Lantz seconds (8-0-0)
- Street lights: \$11,500 Deficit as some lights needed repaid when they were turned back on. Jenkins moves, Ferreira seconds (7-1-0)
- Schools: \$5400 Town expense. We submit for Medicaid reimbursement through school. Person doing reimbursement worked more hours than expected. Ferreira moves, Lantz seconds (8-0-0)

FALL TOWN MEETING SCHEDULE AND SUMMER FINCOM SCHEDULE

Two articles expected from the planning committee. One article (on flood hazards) should be straightforward, but the second (rezoning village) may be more controversial. May also be article to amend Lincoln Park 40R. Some collective bargaining articles (i.e. changing grades for some positions in library) as some money will need to be moved between lines. Quinn bill reimbursement changes will cost us extra 160K+.

Next FinCom meeting will be on Tuesday August 11th. FTM is October 20th.
