GREETINGS:

In the name of the COMMONWEALTH OF MASSACHUSETTS, you are hereby directed to notify and warn the inhabitants and voters of DARTMOUTH FIRE DISTRICT NO. 3 of the TOWN OF DARTMOUTH qualified to vote at district meetings to meet at Station One, 140 Cross Road, North Dartmouth, Massachusetts on Monday, August 4, 2014 at 7:00 P.M. to take action on the following articles which have been unanimously sponsored by the Prudential Committee:

- Article 1.** To have the District nominate and appoint a moderator to preside over this Special Meeting (Rate \$100.00 per meeting).
- Article 2.** To see if the District will vote to appropriate \$1,500,000, or any other sum of money, to pay additional costs of the rehabilitation and reconstruction of, an addition to Fire Station No 1, including, planning, design, engineering and all other costs incidental or related thereto; to determine whether this appropriation shall be raised by borrowing or otherwise; or to take any other action relative thereto.
