Minutes: March 3, 2014 Minutes approved unanimously.

31 McCabe Street; demolition proposed; boarded up for some time. Motion made, seconded, and voted, 7 yeas, 2 abstentions that the building in no longer historically significant.

## Old Business:

CPC update: Peggy reported that CPC approved the Apponegansett Meeting House Roof Restoration project of \$50,850. It also voted a condition in the grant agreement that the Dartmouth Monthly Meeting of Friends must submit a budget and plan for the ongoing maintenance of the property.

Russells Mills Library Update: Windows been replaced; next to be done the additional shutters on the north & south sides of the building; electric service box has been replaced; old wire on exterior been updated;

Stone Barn Report: Deborah Melina Wender has been communicating with Audubon to try to get the remaining issues resolved on the PR.

TTL update: Judy reported that it has finished the current year and has provided a final report. Bills from ttl: March 14, \$8,120 and March 28, \$3,480 for a total of \$11,600. Motion made, seconded, and unanimously voted to approve both bills.

Plaque program: Susan presented alternative proposals. She suggested we look at 8 Winter St.; Elm to Winter; take a right; metal on old wood. George Nelson, 15 Summer St.; composite with sticker. End of High St.; end of Elm first house the left. Corner of 3 Pleasant & Fremont; on metal.

Russell Garrison: National Register nomination: The PR issue has still not been settled.

Russells Mills Proposed Street Lights: Judy reported that there were many comments at the meeting. There was no electricity in Russells Mills until 1930s. The hearing is continued to May 6. Judy will attend.

Dartmouth 350: Judy suggested we visit the website to see what is happening and where to volunteer.

Exterior of Buildings: Advice to residents: Damon has begun to research. He has gathered examples. He will move further.

Re Book on Smith Mills. Motion made, seconded, and voted to authorize use DHC photographs and files. Any profits would go to moving the old North Dartmouth Library. The vote was 8 yes 1 opposed only in relation to use of photos.

Telecommunications Tower, 300 Gulf Road: Judy read Stuart McGregor's letter to CPC. He indicated if Concordia does not do it, a neighbor will. See attached. Judy tried to reach the person at EBI Consulting and been unsuccessful.

Scanning old form Bs: Gregg Barnes is letting us use his sophisticated copier.
