REGULAR BOARD MEETING MONDAY, AUGUST 11, 2014

The Regular Board Meeting of the Dartmouth Housing Authority was called to order at Solemar at 2:00 p.m. by Chairman Elaine Lancaster. Those in attendance and constituting a quorum included Wayne Whalley, Raymond Souza, Constance Desbiens, Executive Director, Kerrie Bosse and a few tenants. Sam Jonsson and Maria Connor were excused.

The pledge of allegiance was lead by Elaine Lancaster.

The Treasurer's Report was presented as follows:

Balances: 667-1 - \$108,955.74; 667-2 - \$167,551.25; Local Programs -

\$44,288.00; S.E.M. - \$276,635.28; Revolving - \$42,950.49

Bills Paid: 667-1 - \$13,683.33; 667-2 - \$65,426.44; S.E.M. - \$26,142.48

Local Programs - \$1,375.61 (all on-line transfers).

Communications included the Mass NAHRO Newsletter which was previously emailed to the Board.

The Executive Director reported on the following items: (the Board was given an outline of this report for easier access to the information given).

- There are two vacancies at Munroe Terrace. The waiting list is as follows; 5 transfers, 4 elderly veteran residents, 5 elderly residents, 10 non-elderly residents, 15 elderly non-residents and 16 non-elderly non-residents.
- Munroe Terrace is scheduled for REAC Inspections on September 10th. DHCD Conducted a pre-REAC on July 17th and 18th. For the most part, apartments were in good shape with just a few tenants receiving notices of "Failures" due to housekeeping or other minor infractions (i.e. blocking egresses, overloading an electrical outlet).
- ➤ The Regionalization Bill has been signed by the House and Senate; and the Governor signed it on 8/7/2014.
- > Connie will be on vacation for the rest of the week.
- Conditions Assessment-to be done by EMG to assess property as it pertains to our Capital Plan.
- > Capital Plan approved, small projects to begin shortly.

## NEW BUSINESS: (all items require Board vote)

- ➤ A vote will be needed to accept the Fee Schedule of \$130 a month for Section 8 Central Waiting List with MOU w/ MassNAHRO.
- Limited English Proficiency (LEP) Policy-for Board review with vote in September.
