The Treasurer's Report was presented as follows:

The Executive Director reported on the following items: (the Board was given an outline of this report for easier access to the information given).

- ➤ There is one vacancy at Sol-E-Mar. The waiting list is as follows; 3 elderly veteran residents, 2 Non-elderly Veteran Resident, 13 elderly residents, 13 non-elderly residents, 18 elderly non-residents and 26 non-elderly non-residents.
- Capital Plan: closet doors will be installed over the next few weeks and the patio wall (outside of the community center) will be repaired. Our next Capital Plan is slated to be worked on at the end of this month and will be brought to the tenants and Board on June 8th.
- ➤ Job Description; in packet as requested. In July, we will begin the process of redefining the front office staff/responsibilities in preparation of hiring a new person to take Rose's place.
- Annual Conference; May 18th-20th in Hyannis.
- > Roof: Building 7-received 3 bids; need to discuss under New Business with a vote.
- > Grievance Officers; Debbie Raymond has resigned; need replacement.
