#### APPROVAL OF MINUTES

The minutes of the November 9 meeting were approved.

#### FINANCIAL DIRECTOR

Mr. Pereira commented that the capital outlay line caught his attention and explained that it was due to the purchase of new scanners for the new computers. Otherwise, the report is on track.

# **DIRECTOR'S REPORT**

Roof replacement: Mr. lacaponi will whittle down to three the fifteen proposals which were submitted. Ms. Medeiros does not mind if he makes the final selection.

Town Web Site Committee: The committee has met twice. Mr. Pereira agrees that policies and procedures need to be set up as guidelines to move forward. Members are in the process of examining the web sites of other towns which have won awards. The difficulty is in knowing what the different departments need.

# DARTMOUTH LIBRARY FOUNDATION

Ms. Aisenberg suggested that specific help requirements be posted on library website. Ms. Sharek recommended press releases. January 25 is the date of the event. Baked goods are needed.

## **CORRESPONDENCE**

The deadline for applying for the LSTA FY 2010 grant is December 15. At Ms. Aisenberg's suggestion that the library should apply, Ms. Medeiros explained that this grant is available every year and that she feels

that program restraints may inhibit our doing the program with a cut budget, that we may not be able to move forward.

#### **OLD BUSINESS:**

#### PRIVATIZATION REPORT

Ms. Medeiros has put together some notes on the benefits of library certification. A library forum has been scheduled for January 14 at Dartmouth High School.

The Trustees will be meeting with the Finance Committee on December 18.

A report of the effects of outsourcing and the benefits of the SAILS network will be sent to the Finance Committee ahead of time.

Ms. Aisenberg requested a transparent financial sheet with potential cost consequences of outsourcing to LSSI.

# **BUDGET FY 2010**

Ms. Medeiros is working on the budget due January 13, 2009. A discussion as to possible cuts and their effects ensued.
