The Chairman opened at 7:47 p.m. the public hearing¹ concerning a request by the Dartmouth Department of Public Works to remove trees on two scenic roads. On Reed Road, the request is to remove 53 Oak and Pine trees ranging in diameter from 2" – 14", located along the frontage of lots 1-2 and 1-14 of Assessor's Map 66. On Collins Corner Road, the request is to remove 15 Oak and Pine trees ranging in diameter from 4" to 24", located along the frontage of lot 5-4 of Assessor's Map 79.

All Planning Board members and Planning staff were present.

A motion was made by Mrs. Miller, seconded by Mr. Larrivee for discussion, and unanimously voted (5-0), to waive the reading of the legal notice, which appeared in <u>The Chronicle</u> on Wednesday, March 30, 2011, and again on Wednesday, April 6, 2011.

The Chairman asked proponents to speak.

Paul Pacheco, representing the Department of Public Works, provided a detailed overview of this request. He spoke about improving the drainage, the proposed removal of trees along Reed Road, the proposed removal of trees along Collins Corner Road, and an explanation of the various tree flagging.
