Edward Iacaponi presented the Board with information on the Health Insurance effective as of June 1<sup>st</sup> we have changed to HMO New England. Mr. Iacaponi stated this is a savings of \$70,704 per year. He mentioned there was also a 5% reduction in Health Insurance for 2008 which is a savings of \$513,000 and the remainder of money will be put back in the general fund.

Edward Iacaponi, Director of Budget and Finance, informed the Board effective July 1, 2008, the Dartmouth Town Collector has implemented a lock box service for the collection of receipts and selected was Citizens Bank. The Town Collector's office will also continue to collect, Water & Sewer fees, Pay-As-You-Throw fees, Personal Property taxes, Excise taxes, Boat taxes, etc., over the counter. He stated the implementation of this service has met one of the goals of the Select Board by streamlining financial operations of the town in conjunction with the Department of Revenue recommendations.
