### **6:35/Hearing-Application of Trio Café & Lounge, Inc. d/b/a Trio Café & Lounge, for a Year Round All Alcoholic License at 780 State Road under the provisions of M.G.L. Ch. 138. The manager on record is Brian Carvalho.**

Brian Carvalho, Tony Rodrigues and Paul Rodrigues were present for the Application of Trio Café & Lounge.

### **6:40/Meeting with representatives of Prime Engineering & BankFive-Discussion on new building project.**

Richard Rheaume, Owner of Prime Engineering, informed the Board this area is at the southeast corner of the property adjacent to Mosher Lane. Mosher Lane, in this location, is an unimproved unaccepted private way. They determined that if a portion of Mosher Lane, which is a private way, were discontinued, a practical office building could be constructed. He stated that the Davis Cemetery which abuts a portion of

Mosher Lane is owned by the Town of Dartmouth; therefore, the Town would appear to own to the centerline of Mosher Lane, subject to the rights of others to pass and repass. He requested the Select Board consider supporting the discontinuance of this portion of Mosher Lane and the conveyance of fee simple title of that portion of Mosher Lane that the Town owns to BankFive.

Michael Gagne mentioned that a form 910 was submitted to the Collectors office shows this was paid by his wife Laurie Gagne in May. Michael Gagne stated he has always paid for all fees and services to the Town of Dartmouth.

The Executive Administrator mentioned the RFP for the Schofield Farm will be issued on September 17, 2008. It will appear in the Central Register that Day. Mr. Gagne stated anyone who is interested will have until October 10, 2008 to be qualified by BankFive for an affordable loan and have until October 17, 2008 to submit their completed packet to the Treasurers' Office. The winner will be chosen by lottery at the Select Board meeting on October 20, 2008 and the name of the winning applicant will be presented to Town meeting on October 21, 2008 for approval of the sale. The closing must occur before November 7<sup>th</sup>, 2008. Preference will be given to a "Qualified Income Eligible Dartmouth Farmer."
