Mark Eisenberg, Chairperson of the Executive Administrator, briefed the Board on the process of the search company. Mr. Eisenberg requested a favorable vote from the Select Board.

Report of Finance Director concerning Governor's Fiscal Presentation on January 23, 2009.

Edward Iacaponi, Director of Budget and Finance presented the Board with the 9th revision of the expense projections for FY 2008-FY 2013. Mr. Iacaponi stated after the Governor's presentation on January 23, 2009 with the numbers our shortfall for 2009 will be \$509,000. Mr. Iacaponi stated he would have the FY 2010 numbers after he meets with the Governor on January 28th. The Director of Budget and Finance discussed the following for FY 2010 budget reductions and capital needs.

- * Elimination of all money for part-time clerical help for boards.
- * Elimination of overtime/non-police and DPW.
- * Recreation Department becoming 100% self-sufficient.
- * Reduction of Park Department operations.
- * Elimination of part-time Natural Resources Shellfish officer.
- * Reduction of 15% at Department of Public Works.
- Reduction in Health Department.
- * 15% reduction in Library Department operations.
- * Reduction in Treasurer's Office of 20%.
