Ms. Copley mentioned it's highly competitive and based on a point system. The town starts off with 25 pts compared to other towns who could start with as many as 10 extra points.

Ms. Copley explained the 2008 application awarded last July was for Human Resources and Public Facilities. It will fund 10-15 HR projects plus the \$72,000 ADA handicap concrete ramps, deck and stairs for the Bullard Wellness Center to be occupied by the Community Nurses.

Ms. Copley mentioned the FY 2010 application, should the Board decide to apply again, is looking to assist the town with the DPW's Dartmouth project. If funded, it will pay for resurfacing, curbing, sidewalks and water mains for the Potter St project, in addition to 5-10 Human Resources projects within the Bliss Corner target area.
