6:30/Park Commission re: Continued discussion on Reducing Beach Sticker Fees.

Tim Lancaster, Superintendent of Parks, stated to the Board that we have calculated revenue numbers with a cost of \$45/\$25 sticker rate for the purpose of reinstating staff for increased life guarding, maintenance and office assistance work based on actual 2005 staffing hours.

Members of the Select Board stated they would like to see this number cut in half to \$35/\$25.

Members of the Select Board stated the Town is giving the Park Department \$52,000 and will also absorb any negative outcome on the Park Budget.

Selectwoman Lara Stone asked about fee for Handicap individuals, she feels this should be a put to zero.

Mrs. Lake, member of the Park Board spoke on this issue. She stated based on the information provided to the Park Board that \$52,000 would be funded though the Town. The Park Board came up with the proposed \$45/\$25, however after hearing from the Board, it appears that they would like the number to be at \$35/25 we will have to present this back to our Board.

The Superintendant stated he will present this information to the Park Board and attend another Select Board Meeting in November.

Wendy Henderson, Director of Public Health updated the Board on H1N1 (Swine Flu) Wendy Henderson stated the H1N1 vaccine has started to arrive in Massachusetts in very limited quantities. She mentioned that the vaccines are going to local Pediatrics and Ob-Gyn practices as top priority. The Director of Public Health stated no State Laboratories cases in Dartmouth have been confirmed however, the schools are seeing an increase in the N1N1 Flu like symptoms. She mentioned that the schools, teachers all have been educated with brochures; given masks and ways to prevent the spreading of Flu.
