# 7:00/Continued Public Hearing on the Application of the Alternative Energy Committee requesting a Special Permit for Two Wind Turbines on Chase Road.

Ron DiPippo, Chairman of the Alternative Energy, addressed the hearing by responding to questions and concerns raised at the first session of the public hearing.

The Board is the special permit granting authority for such projects under the town's commercial wind turbine bylaw, a super majority of four of the five board members is need for approval of the permit.

The Board heard from many neighbors. Some complained about the noise, shadow flicker and safety issues during the public hearing and worried about the valuations of their homes dropping because of their proximity to homes.

Selectman Trimble addressed concerns raised by residents in opposition. Selectman Trimble stated, "there doesn't appear to be any realist health and safety concerns, or potential significant negative impact on property values for homes surrounding the proposed site."

A motion was made by Selectman William Trimble to vote on a Special Permit for Two Wind turbines on Chase Rd, with no second coming the motion failed.

The remaining Board members felt more time was needed to look into issues raised by residents.

After a motion was made by Selectman Michael Watson and seconded by Vice-Chairperson Nathalie Dias, it was voted (4) four in favor and (1) one opposed (Selectman William Trimble) to continue the hearing for a Special Permit for Two Wind Turbines on Chase Road until January 4, 2010.
