After a motion was made by Selectman William Trimble and seconded by Selectwoman Lara Stone, it was voted (4) four in favor and (1) one opposed (Selectman Watson) to approve the Application for Solicitation by Antonio Arruda with the modification of solicitation times from 9:00 a.m. to 6:00 p.m. and no solicitation on Sundays or Holidays.

The Executive Administrator updated the public on the Harbormaster Contract. An agreement was reached for a 3 year contract with the same pay just slightly under \$68,000 with no "Evergreen Clause".
