# **New Business:**

## **Deputy Chief of Police Contract.**

Select Board Meeting 1 May 3, 2010

The Executive Administrator stated that the contract of the Deputy Chief is similar to the Contract Gary Soares had when he was Captain. The Executive Administrator noted some of the changes in the Contract.

- 1.) Title Change.
- 2.) Salary Change: Base Salary plus Police Officer Career Incentive Pay with a \$110,000 cap.
- 3.) Three year Contract.
- 4.) A Leave of Absence provision to retain his civil service status as a Police Captain.

The Chairperson voiced his concerns about keeping the Contracts to a one-year Contract versus a three year Contract.

After a motion was made by Vice-Chairperson Michael Watson and seconded by Selectwoman Lara Stone, it was voted unanimously to approve the Deputy Chief of Police Contract.

### **Director of Development Employment Agreement.**

After a motion was made by Selectman Joseph Michaud and seconded by Selectman Shawn McDonald, it was voted (4) four in favor and (1) one opposed (Chairman Trimble) to approve the Director of Development Employment Agreement.

Chairman Trimble opposed because he would like to see a one year contract.
