The Chairman opened the Public Meeting at 5:45 p.m.

The Chairman polled the Board for a roll call vote to convene into Executive Session Pursuant to M.G.L. Ch. 39 Sec 23B: Selectman Michaud, yes; Selectwoman Stone, yes; Vice-Chairperson Watson, yes; Chairman Trimble, yes.

The Chairman reconvened the meeting at 6:30 p.m. on July 26, 2010 in room 304.

6:35/Application of Friends Academy for a One-Day Common Victualler License to benefit the Schwartz Center for Children for August 14, 2010.

Carol Almeida, Director of Human Resources for the Schwartz Center, was present for the Application.

After a motion was made by Selectwoman Lara Stone and seconded by Selectman Joseph Michaud, it was voted unanimously to approve the Application of Friends Academy for a One-Day Common Victualler License to benefit the Schwartz Center for Children for August 14, 2010.

6:40/Hearing-Application of Dartmouth Country Club Inc. d/b/a Hawthorne Country Club for alteration of the licensed premises for a seasonal snack/beverage cart to serve Alcoholic Beverages.

The Chairman opened the Hearing.

A Representative from the Dartmouth Country Club was present.

The Select Board requested the following conditions.

Only those alcoholic beverages sold or delivered by the licensee may be consumed and possessed by patrons on the grounds of the golf course.

No Patrons of the golf course shall possess or carry alcoholic beverages in or a public way.

The licensee shall conspicuously post easily read signs stating "no alcoholic beverages permitted beyond this point" at the entrance.

Parking lots for the golf course shall be treated as though they were public ways.

No more than two drinks shall be sold, delivered or in the possession of any one patron at any one time while on the grounds of the golf course.

The Chairman closed the Hearing.

After a motion was made by Selectman Joseph Michaud and seconded by Selectwoman Lara Stone, it was voted unanimously to approve the Application of Dartmouth Country Club Inc. d/b/a Hawthorne Country Club for alteration of the licensed premises for a seasonal snack/beverage cart to serve Alcoholic Beverages subject to above conditions.

6:45/Appointment with Edward Jagielski re: 35 George St.

Edward Jagielski expressed his concern with puddles in this driveway resulting from the recent installation of new sidewalks.

Lee Azinheira, Board of Public Works, and David Hickox, Superintendant of the DPW were present.

The Superintendent mentioned the DPW Board reviewed the photos of the site detailing the extent of puddling and all were in agreement that the noted puddles were attributed to the age of the driveway and were not caused by construction of the new sidewalks. David Hickox stated the Board did acknowledge that some restriction of runoff from the driveway may be attributed to the new sidewalk but concluded that the impact was negligible as any puddles that may have developed adjacent to the sidewalk dissipated immediately after the rain event.

The Superintendent stated the Board voted to revisit the subject this winter should a problem with icing occur as a result of the sidewalk installation.

Select Board members were in agreement with this decision.

6:50/Application of the Blowout Committee for a One Day Beer & Wine License for August 14, 2010.

Mr. John Haran was present for the Application.

After a motion was made by Selectman Joseph Michaud and seconded by Vice-Chairperson Michael Watson, it was voted unanimously to waive the \$100 tent for this application.

After a motion was made by Vice-Chairperson Michael Watson and seconded by Selectperson Joseph Michaud, it was voted unanimously to approve the Application of the Blowout Committee for a One Day Beer & Wine License for August 14, 2010.

7:15/South Coast Corridor Plan.

Christine Egan, Director of Southcoast Rail Corridor Plan and Nancy Durfee, SRPEDD briefed the board on the South Coast commuter Rail Project and priority Development and protection of areas in Dartmouth. The plan also identifies priorities for land protection, which will preserve the farms, field and forests in every city and town. Protecting working farms, cranberry bogs, habit, rivers and wetlands is not only important for ecological reasons, but for economic reasons.

Selectperson Lara Stone left the meeting.

6:55/Application of Tess Bettencourt for a One Day Beer & Wine License for August 7, 2010 for a wedding.

Applicant did not show up for the Application.

The Board agreed that the developers should meet with the Smart Growth Overlay and they can make recommendations to the Select Board.
