## **New Business:**

#### **Bullard Center Lease.**

The Executive Administrator presented the Board with the Bullard Lease. Mr. Cressman stated that this lease is good through 2013.

After a motion was made by Vice-Chairperson Michael Watson and seconded by Selectman Shawn McDonald, it was voted unanimously to approve the Bullard Center Lease.

The Executive Administrator updated the Board on the Amendment to the Ambulance Contract; the Contract amount is being reduced from \$328,000 to \$248,000.

After a motion was made by Selectman Joseph Michaud and seconded by Vice-Chairperson Michael Watson, it was voted unanimously to sign the Amendment to the Ambulance Contract.

Selectwoman Lara Stone requested that the Town receive a quarterly update from STAT Ambulance on response times in Dartmouth.

#### **Updated status report on Double Poles.**

The Executive Administrator updated the Board on the number of Double Poles which is down from 383 last year to 145 this year. Mr. Cressman stated that this is a big improvement.

Selectwoman Lara Stone informed the Board that the Dartmouth Disability Committee is going to be doing a survey.
