#### Board to vote to set the Annual Town Election.

A discussion ensued about changing the date of the Town Election or combining the Town Election with the State Election. The Board suggested the Town Clerk come to the next meeting to further discuss the options.

After a motion was made by Selectman Joseph Michaud and seconded by Vice-Chairperson Michael Watson, it was voted unanimously to table this matter pending more information from the Town Clerk.

#### Ambulance Contract.

The Executive Administrator was commended for his hard work in reducing this contract, in which Stat Ambulance will be paying the Town about \$40,000 annually to help defray the costs of dispatching.

After a motion was made by Vice-Chairperson Michael Watson and seconded by Selectman Shawn McDonald, it was voted unanimously to approve the ambulance contract.

The Board discussed a recent resignation of Harry Bichsel from the Library Board of Trustees. As per the Town Charter, we should have a joint meeting with the Library Board of Trustees to appoint a candidate on December 13, 2010.

After a motion was made by Selectwoman Lara Stone and seconded by Vice-Chairperson Michael Watson, it was voted unanimously to have a joint meeting with the Library Board of Trustees on December 13, 2010.

Selectwoman Lara Stone mentioned there was a letter sent from the First Lady encouraging mayors and elected officials to adopt a long-term, sustainable and holistic approach to fight childhood obesity.

After a motion was made by Selectwoman Lara Stone and seconded by Vice-Chairperson Michael Watson, it was voted unanimously for Dartmouth to be a "Lets Move Community".

Selectwoman Lara Stone mentioned a recent newspaper article regarding New Bedford's exclusion from \$5.5 million from a federal fund aimed at mitigating environmental damage caused by PCB contamination in New Bedford Harbor has drawn the ire of Mayor Scott W. Lang, who says he'll work to reverse the recommendation by the New Bedford Harbor Trustee Council.

The Executive Administrator will represent our Town at a public hearing on November 23, 2010 at 6:30 p.m. and read a letter of support for the project in Dartmouth.
