Update on the Boatyard Pub & Grill.

Attorney Matthew Aspden was present representing the Boatyard Pub & Grill.

# Steven Sharek, Moderator re: Proposal for Establishment of a Municipal Facilities Committee.

Steven Sharek, Moderator, briefed the board on the Proposal for Establishment of a Municipal Facilities Committee. Mr. Sharek stated the purpose of this committee will be to investigate and make recommendations to Town Meeting and the respective town departments on the highest and best uses for municipal buildings. The Committee will report to Town Meeting at least once per year, and will remain active until disbanded by vote of Town Meeting.

After a motion was made by Selectwoman Lara Stone and seconded by Selectman Joseph Michaud, it was voted unanimously to support this article for Town Meeting.

#### Update on Joe's Used Cycles.

Paul Murphy, Director of Inspectional Services, briefed the board on Joe's Used Cycles. Mr. Murphy stated that Joe's Used Cycles is still not in compliance, however, he feels Mr. McConnell has made a big improvement, cleaned up a lot and made a great deal of progress to date. Mr. Murphy mentioned that after speaking with Mr. Connell he needs more time, until the end of June.

Joseph McConnell was present for his appointment with the Board.

After a motion was made by Vice-Chairman Michael Watson and seconded by Selectman Joseph Michaud, it was voted unanimously to grant Joe's Used Cycle a three month extension from March 10, 2011 to June 30, 2011 and that he must be in compliance with all regulations.
