The Board discussed the Insurance and decided to keep Sylvia Insurance as our broker but will change the underwriter. The Executive Administrator mentioned that he has had numerous problems with Trident Insurance with the way the company handled their claims. Mr. Cressman will be meeting with Travelers Insurance on April 6th and will update the Board at the April 11th Meeting.

Discussion on Ad Hoc Sub Committee for RFP to hire a consultant to review efficiency opportunities in Town Government.

A discussion ensued about streamlining and making Town Government more efficient. We are trying to accomplish this through the Town Charter starting with making all Department Heads report to the Executive Administrator. Some members of the Board felt that the timing would be an issue since we are trying to change the Town Charter. Vice-Chairman Watson stated we are in our final stages of the Town Charter; this needs to be reviewed by Town Counsel and should be available for the Select Board to review sometime in June.

After a motion was made by Selectman Joseph Michaud and seconded by Vice-Chairman Michael Watson, it was voted unanimously to form an Ad Hoc Committee consisting of a Select Board Member, Executive Administrator, Finance Committee, School Committee Member, and designee, to develop an R.F.P. this R.F.P.; must be approved by the Select Board.

Selectman Joseph Michaud will serve as a member from the Select Board and David Cressman as Executive Administrator.
