Board of Selectmen

Select Board Members Present:

The Chairman called the meeting to order at 6:30 p.m. on April 11, 2011 in room 304.

Reorganization of the Board.

After a motion was made by Selectwoman Lara Stone and seconded by Selectman Shawn McDonald, it was voted unanimously to appoint Michael Watson as the Chairman.

After a motion was made by Selectman Shawn McDonald and seconded by Chairman Michael Watson, it was voted unanimously to appoint Selectwoman Lara Stone as Vice-Chairwoman.

Application of Holy Ghost Society of Horseneck for a One Day Liquor License (see attached dates) and a Common Victuallers License.

Wayne Raulino, President of Holy Ghost Society of Horseneck, was present for his application.

After a motion was made by Vice-Chairwoman Lara Stone and seconded by Selectman Shawn McDonald, it was voted unanimously to approve the Application of Holy Ghost Society of Horseneck for a One Day Liquor License (see attached dates) and a Common Victuallers License.

Application of Smith Mills Christian Congregational Church for a Common Victuallers License.

Lizzie's Liquors-Pledge of Liquor License.

Wassim Chedid, President of Lizzie's Liquors, was present for his Pledge of Liquor License.

After a motion was made by Selectman Shawn McDonald and seconded by Selectman William Trimble, it was voted unanimously to approve the Pledge of Liquor License for Lizzie's Liquors.

Appointments to the Veterans' Advisory Board.

Edward Pimental Jr. and Charles Ditata briefed the Board on their work experience.

After a motion was made by Selectman Shawn McDonald and seconded by Vice-Chairwoman Lara Stone, it was voted unanimously to appoint Edward Pimental, Jr. and Charles Ditata to the Veterans Advisory Board.

New Business:

Appointments to the Joint Transportation Planning Group for SRPEDD.

After a motion was made by Selectman Shawn McDonald and seconded by Selectman William Trimble, it was voted unanimously to appoint David Hickox as the Delegate and

Steven Sullivan as an Alternate to the Joint Transportation Planning Group for SRPEDD.

Renewal Application for Buns on the Run Too for a Common Victuallers License.

After a motion was made by Selectman Shawn McDonald and seconded by Selectman William Trimble, it was voted unanimously to approve the Renewal Application for Buns on the Run Too for a Common Victuallers License.

Resignation letter from Sylvia C. Friedman, Dartmouth Veterans' Advisory Board.

After a motion was made by Selectman William Trimble and seconded by Selectman Shawn McDonald, it was voted unanimously to accept the resignation from Sylvia C. Friedman, with regrets.

Chapter 90 Allocation.

The Executive Administrator informed the Board that the Chapter 90 local transportation aid funding for Fiscal Year 2012 will total \$200 million statewide. The Executive Administrator stated to the Board that the Town of Dartmouth's Chapter 90 for FY2012 is \$1,173,867.

Review of FY2011 Local Receipts & Expenses.

Greg Barnes, Director of Budget and Finance/Treasurer, updated the Board on the third quarter Local Receipts and some transfers that we will have to make next quarter. The Director of Budget and Finance went over the Variance for actual receipts for FY2011 noting that we have collected \$663,400 more so far this year due to the Room Occupancy Tax and Meals Tax was \$410,366.

Shellfish Program.

The Executive Administrator informed the Board that with the resignation of the Town's part-time Shellfish Constable he had some discussions with the Town's Harbormaster and the Waterways Commission as to how to operate this program now and in the future. The Executive Administrator stated he would recommend that we form a subcommittee consisting of a Select Board Member, Waterways Commission Members, Harbormaster & himself to address this issue.

After a motion was made by Selectman Shawn McDonald and seconded by Selectman William Trimble, it was voted unanimously to appoint Vice-Chairwoman Lara Stone to serve on the Sub-Committee.

The Board was in support of the Executive Administrator to research other options such as regionalization.

Mass Audubon-waiver of the Building Permit Fee for the interior demolition of two barns.

The Executive Administrator mentioned that Mass Audubon has undertaken the renovation of two barns at the Stone Barn Farm in Dartmouth, with a generous grant of the Town's Community Preservation Act Funds. They are requesting a waiver of the building permit fee that is required for this demolition work to proceed.

After a motion was made by Selectman Shawn McDonald and seconded by Selectman William Trimble, it was voted unanimously to reject waiving the fees for the building permit.

Old Business:

Snow & Ice Budget.

The Select Board reviewed the Snow & Ice Budget; the Town has spent \$273,388.93 over the budgeted amount as of April 4, 2011.

The Executive Administrator informed the Board that they need to sign a Waiver of Right of First Refusal for Lot 24 shown on Dartmouth Assessors Map 49 in connection with the sale by Ronald T. Bogusky and Barbara Purdy.

After a motion was made by Selectman Shawn McDonald and seconded by Selectman William Trimble, it was voted unanimously to sign this Waiver of Right of First Refusal for Lot 24 shown on Dartmouth Assessors Map 49.
