6:30/Application of Chuck E Cheese for a change of Officers/Directors.

New Business:

Renewal Application of TGI Friday's for Amusement Devices.

After a motion was made by Selectman William Trimble and seconded by Selectman Joseph Michaud, it was voted unanimously to approve the renewal application of TGI Friday's for Amusement Devices.

Department of Public Works/Water Division Community Award.

The Chairman announced that the Water Division was the recipient of the Massachusetts Water Works Association Community Award for exemplifying the highest standard of water works practice.

Agreement for Legal Services.

Legal Agreement between the Town and Attorney Howard Greenspan for the period of July 1, 2010 through June 30, 2011.

After a motion was made by Selectman Joseph Michaud and seconded by Vice-Chairwoman Lara Stone, it was voted unanimously to adopt the Agreement between the Town and Attorney Howard Greenspan.

Heritage Wharf Company, LLC The Red Oven, Inc.

The Executive Administrator informed the Board that he and Town Counsel have reviewed Atty. Rudolph's letter on this subject. While the letter has made a series of assertions concerning the relationship between his client and the Red Oven Inc., there is not documentation to support the assertions. Thus, he and Town Counsel would suggest that the Select Board's response would be to request that Atty. Rudolph provide such documentation or Mr. Nolan will take action against Mr. Mendonca and Red Oven, Inc.

Select Board members agreed to bring the parties together to try to resolve this situation.

Fiscal FY12 Budget.

Analysis reflects the opportunity the Select Board and Finance Committee have to consider certain financial policy decisions for the FY 2012 Budget. It should be noted that in the attached analysis there is a \$444,403 balance. Except for the School Transportation number of \$92,820, the attached analysis identified how this amount can be allocated.

The Executive Administrator recommends the following policies:

- -Expenditures should reflect the reality of Town operations and attempt to avoid or reduce the magnitude of budget transfers or deficit spending.
- -Start to reflect costs for annual capital expenditures and unfunded retiree health insurance benefits in the Town's expenditure base.
- -Reserve certain appropriations for unforeseen events related to gasoline costs and/or the development of better plans to spend appropriations.

The Police Chief briefed the Board on his budget, informing the Board that he would like to add three more officers. Chief Lee stated that the E 911 Grant will pay for one dispatcher's salary.

After discussion on the FY2012 budget, Select Board members felt that there needs to be a joint meeting with the School Department and Finance Committee.

This issue will be on the agenda for the next Select Board Meeting.
