I. Appointments

6:30 pm -Hearing Tax Classification

The Chairman opened the Hearing.

Paul Bergman, Administrator of Assessing, presented the Board with the necessary information to set the tax rate. The following are the percentages for this year and the previous six years as follows:

The Town has the option of establishing one tax rate for all classes of property or shifting part of the R-O Tax Levy to the CIP Classes. The shift cannot exceed 150% of the CIP percentage allocations.

In FY2011 the Board voted to continue shifting 40% to the CIP Classes. The resulting percentages of the Tax Levy were Residential- 77.01% and CIP-22.9% In addition, the small commercial exemption was continued at the maximum 10%.

If the Board elects to maintain the same shift this year the Residential share would go up slightly from last year's 77.01% to 77.06% with the CIP ticking down to 22.94%.

The Chairman closed the Hearing.

After a motion was made by Selectman William Trimble and seconded by Vice-Chairwoman Lara Stone, it was voted unanimously to approve the 40% commercial tax split.

After a motion was made by Vice-Chairwoman Lara Stone and seconded by Selectman Shawn McDonald, it was voted unanimously to approve the Small Business Exemption.

After a motion was made by Selectman William Trimble and seconded by Selectman Shawn McDonald, it was voted unanimously to approve the Black Friday applications for Toys R' Us and Target retroactively.

-Charter review standings are in and Selectman Joseph Michaud would like the Select Board to support the Municipal Efficiency Study Group in getting a cost analysis to see how we can improve Town government by making it more efficient and cost effective.

After a motion was made by Selectman Joseph Michaud and seconded by Selectman William Trimble, it was voted unanimously to move forward with the Municipal Efficiency Study Group.

-Vice-Chairwoman Lara Stone formerly resigned from TRG, and then recommended that Selectman William Trimble represent the Select Board going forward.

After a motion was made by Vice-Chairwoman Lara Stone and seconded by Selectman Shawn McDonald, it was voted 4 in favor and 1 abstention (Selectman William Trimble) to nominate Selectman William Trimble as the TRG representative.
