I. Appointments:

6:30 p.m. Attorney Daniel Perry re: Notice of Intent to Sell Land-DeCosta Property Lots 18 & 20 on Assessors Map 12.

- 23 acres of land off of Horseneck Rd. for \$195,0000.00
- Zoning opinion was sent out in regards to this property by an abutter without permission of the owners of the DeCosta property.
- Is this a buildable lot? The Town had a letter from the Building Inspector saying it was not a buildable lot.

- Does the Town want to buy the lot for \$195,000.00? The Town has 30 days to decide.
- A hearing will take place on October 15, 2012 to make a decision on the parcel.
- DNRT is interested in exercising its right of first refusal. DNRT would lease the land for farming or resell it for agricultural use only.

After a motion was made by Vice-Chair Shawn McDonald and seconded by Selectman Michael Watson, it was voted unanimously to approve a hearing to take place on October 15, 2012 to decide whether or not the Town will purchase the parcel of land for \$195,000.00.

- C. Lincoln Park Apartments
 - The developer of the Lincoln Park Apartments is Bristol Pacific.
 - Bristol Pacific has requested a letter from the Select Board in support of their application and a contribution of \$100,000 to offset development costs.
 - Affordable Housing Apartments.

After a motion was made by Selectman Joseph Michaud and seconded by Selectman William Trimble, it was voted unanimously to approve sending a letter of support for Bristol Pacific's application from the Select Board.
