**COUNTRY CLUB OF NEW BEDFORD**  
**CONDITIONS FOR USE OF GOLF CART TO SERVE**  
**ALCOHOLIC BEVERAGES ON PREMISES.**

- Only those alcoholic beverages sold or delivered by the licensee may be consumed and possessed by patrons on the grounds of the golf course.
- No patrons of the golf course shall possess or carry alcoholic beverages in or on a public way.
- The licensee shall conspicuously post easily read signs stating “no alcoholic beverages permitted beyond this point” at the following crossings of a public way:
  - Slocum Rd Crossing.
  - Hathaway Road Exit.
  - Slocum Road Exit.
- Parking lots for the golf course shall be treated as though they were public ways.
- No more than two drinks shall be sold, delivered or in the possession of any one patron at any one time while on the grounds of the golf course.
- Patrons may not remove from the golf course any alcoholic beverages purchased on the golf course.

**ALLENDALE COUNTRY CLUB**  
**CONDITIONS FOR USE OF GOLF CART TO SERVE**  
**ALCOHOLIC BEVERAGES ON PREMISES.**

- Only those alcoholic beverages sold or delivered by the licensee may be consumed and possessed by patrons on the grounds of the golf course.
- No patrons of the golf course shall possess or carry alcoholic beverages in or on a public way.
- The licensee shall conspicuously post easily read signs stating “no alcoholic beverages permitted beyond this point” at the following crossings of a public way:
  - Signage at the front entrance.
  - Off 18<sup>th</sup> hole.
  - 1<sup>st</sup> and 10<sup>th</sup> hole.
- Parking lots for the golf course shall be treated as though they were public ways.
- No more than two drinks shall be sold, delivered or in the possession of any one patron at any one time while on the grounds of the golf course.
- Patrons may not remove from the golf course any alcoholic beverages purchased on the golf course.
