"Press Release" regarding Dartmouth Leadership Rescinds Bus Transportation Fees.

DARTMOUTH LEADERSHIP RESCINDS BUS TRANSPORTATION FEES

September 10, 2009, Dartmouth, MA— At a joint meeting of the Select Board, Finance Committee and School Committee of the Town of Dartmouth last night, leaders voted to rescind bus transportation fees for all families for the 2009-2010 school year. The unanimous decision, effective immediately, will allow the town to use some surplus funds for this year to reduce fees for tax-payers. Families that have already paid the fee for this school-year will be reimbursed. All refunds will be processed by mail on or before October 31, 2009.

Further discussion included use of the \$3.5 million in turn-back funds from the 2009 fiscal year. Much of the money is spoken for already based on carefully identified priorities. Dartmouth will be forced to make up the difference locally for reductions in MA State Aid particularly for Chapter 70 education funds and must tackle items from its 5-year Capital Improvement Project list. Many of these projects have been put off for the last 1-3 years due to budget cuts. These include items such as road work, new boilers, police cruisers, snow plows with frames, salt/sand spreaders, and school technology. Funds will also be placed in the Stabilization fund. Town Meeting will vote on these decisions at the October 20 meeting at Dartmouth High School at 7:00 PM.

The meeting closed with a briefing by Dr. Russell, Superintendent of the Dartmouth Public Schools, about the potential costs of funding full-day Kindergarten in Dartmouth. A pilot project is happening this year with 20 children attending full-day in all three elementary schools. A working group with representation from Select Board, School Committee and Finance Committee will be formed to study the feasibility of implementing full-day Kindergarten in 2010. If residents have any questions concerning Bus Transportation reimbursement, they may call the Town Administration Office at 508-997-3391.

The Board authorized Selectman Michael Watson to explore options of Regionalization Animal Control with the Town of Westport.

Vice-Chairperson Nathalie Dias also asked about Regionalization of the recreation Department with the Town of Westport.
