6:30 p.m. Joint Meeting with the School Committee and Finance Committee

- School Security & Interoperability
- Site evaluations are being performed on School Departments for Security/Safety reasons.
- Best practices system is being set up nationwide between Police Departments in regards to school safety.

#### Dartmouth Police Department Staffing

- A staffing request has been submitted by the Dartmouth Police Department.
- Two current vacancies in the Police Department.
- By September Chief Lee will have approximately 6 to 7 vacancies.
- New officers need to be placed in the Academy soon in order to avoid too many vacancies in the winter.
- Chief Lee is upgrading the Command Staff at the Police Department.
- Lieutenants are going to be in Command positions going forward.

After a motion was made by Selectman Michael Watson and seconded by Selectman Joseph Michaud it was unanimously voted (4-0) to approve the temporary position of Acting Deputy Chief to Bob Szala.

After a motion was made by Selectman Michael Watson and seconded by Vice-Chairman Shawn McDonald, it was voted unanimously (4-0) to approve the Dartmouth Police Department to send 7 recruits into the Police Academy in September 2013.

#### <u>Budget Forecast</u>

- Increased local receipts this year.
- No increase in state aid areas this year to date.
- The focus this year is on financing transportation and improving transportation.
- Greg Barnes and Jim Kiely will look at the model in regards to how revenues are distributed and expenses are allocated out.
- Increase in Motor Vehicle commitment.
- The Town is currently on track with the budget.
- Reserve fund may be needed if we receive any more snow or ice.
- Town Meeting is June 4, 2013.

### Efficiency Study

- The Efficiency Study was supported by the Select Board and school Committee but there is a question on how to fund it.
- The Efficiency Study will look at the government we currently have and try to improve it.
- It was questioned as to whether the Efficiency Study will be put on as an Article for Town Meeting?
- The Boards will revisit the issue of the Efficiency Study at the May 7, 2013 Meeting.

After a motion was made by Selectman Michael Watson and seconded by Vice-Chair Shawn McDonald, it was voted unanimously (4-0) to support the Efficiency Study as a Warrant Article for the Town Meeting.

After a motion was made by Jonathan Schwartz (School Committee) and seconded by Bob Oliveira (School Committee), it was voted unanimously to approve the Efficiency Study as a Warrant Article for Town Meeting.

After a motion was made by Doug Roscoe (Finance Committee) and seconded, it was voted to approve with one opposed, the endorsement of an Efficiency Study Warrant Article for Town Meeting.

#### <u>Technology Study</u>

- Two proposals were advertised for this study.
- The Town will utilize UMass students to prepare a Master Plan.
- Using firms that are offering to audit the Towns systems.

Capital Improvement Projects

- A Capital Improvement plan was submitted by Greg Barnes for 2014, 2015, 2016 and 2017.
- Items for borrowing will keep the Town in a level debt spending limit.
- The Streetlight Project will be the top project for borrowing.
- The CIP Committee will go over the projects soon.
- The School Department does not currently have a Technology Director and would like to see a full-time position for a director slotted in the future.
- Technological Infrastructure improvement is a project for the School Department.

#### Potter School Update

- An Innovation Grant application was submitted for a Master plan and the application was not approved.
- 11 projects were accepted out of 275 and Dartmouth's was not one of them.
- Next Potter School Meeting is March 20, 2013.
- Please register your children for kindergarten early, enrollment is open now.
  - Youth Sports Master Plan Update including Skateboard
    Park
- The Master Plan for youth sports is to improve playing field conditions in regards to Athletic Fields in the Town.
- Less transporting of children between fields.
- Improve field conditions.
- Next Meeting is March 13, 2013.
- Possible Skate Park is being discussed for the old basketball park on Slocum Road.
