- 6:45 p.m. Joint Meeting with Planning Board- North Eastern University Capstone Presentation/Padanaram Village Improvements-Members of Northeastern University in the Civil Engineering Department along with Dr. Daniel Dulaski made a presentation showing ideas on how to revitalize the Village area.

II. New Business:

A. Letter of Resignation- John George Jr.-

After a motion was made by Vice Chair Stanley Mickelson, and seconded by Selectman Frank Gracie, it was unanimously voted to approve.

The Board is now faced with the decision whether to continue with a four person Board until April 2015, or hold a special election to fill John George's seat until the election in April 2016. This Special Election will cost the Town around \$25,000. The Board is asking for the residents to call or email their opinions to them in this next week and we will discuss this further and make a decision at the next meeting.

- B. Dartmouth Governance Letter- the purpose of the governance letter is to inform those charged with governance about certain results of the annual audit. This letter will be filed.
- C. Correspondence from City of New Bedford, City Clerk regarding Shaw's Supermarket vendors- The City of New Bedford is sending a letter to Shaw's Supermarkets to ask their venders not to use the back side roads to enter or exit the parking lot for deliveries. The City will also be adding signage to this effect and would like the Towns support.

After a motion was made by Vice Chair Stanley Mickelson, and seconded by Selectman Frank Gracie, it was unanimously voted to also send a letter to Shaw's Supermarket showing support in this decision.

> D. Application for the Bucket, 77 Gulf Rd. for a Common Victualler License – The Bucket will be run by the Park Department this summer and we look forward to everyone's support.

After a motion was made by Selectman Frank Gracie, and seconded by Vice Chair Stanley Mickelson, it was unanimously voted to approve.

> E. Regulations and Licenses for Transient Vendors, Hawkers, Peddlers and Solicitors- Town Counsel has designed a flow chart to help aid in the licensing. There will be an article at the Town Meeting allowing us to place certain Town rules and regulations on licensing, along with a "Do Not Knock" list that you may add your address to so that you will not get solicitors at your door.

After a motion was made by Selectman Frank Gracie, and seconded by Vice Chair Stanley Mickelson, it was unanimously voted to approve.

F. Russell Mills Library Lease-

After a motion was made by Selectman Frank Gracie, and seconded by Vice Chair Stanley Mickelson, it was unanimously voted to sign the Lease.

G. By-Law Review- Establishment of Committee- At least once every ten years a Special Committee will be appointed, consisting of nine members and its purpose is to review the Charter.

After a motion was made by Vice Chair Stanley Mickelson, and seconded by Selectman Frank Gracie, it was unanimously voted to encourage anyone that would be interested in this to submit a letter of interest to the Selectboard.

- H. Local Receipts FY2015- Looking over a the spreadsheets, we are doing well with the adopted budget but there are notes of caution looking ahead.
- I. Auditors Response to Local Mandates Inquiring about Firearms Licensing- Due to the increase in firearm requests, the Town has designated an officer for licensing. The Town gets 25% for the licensing cost (\$25.00) but that does not make a dent in the costs associted with having a designated officer. Unlike other communities Dartmouth conducts a thorough review of the local crime and mental health databases, we also conduct a personal interview with the applicant to decide if they are suitable for gun ownership. The Town had asked the State for more funding but was denied.
- J. Mothas Park- Due to signs of vandalism and illegal dumping the The Park Department is requesting that barricades be placed at the entrance located at the intersection of Mary Crapo Way and Meadowood Drive. These barricades will stop cars from entering the park but there will still be access by foot.

After a motion was made by Vice Chair Stanley Mickelson, and seconded by Selectman Frank Gracie, it was unanimously voted to approve.

K. Common Victuallers License – John George Farms Ice Cream Parlor

After a motion was made by Vice Chair Stanley Mickelson, and seconded by Selectwoman Kelli Martin-Taglianetti, it was unanimously voted to approve.

The Board would like the residents to know that the solicitors from Energy Companies that are going to residents doors to try and get them to sign up for their Company. They may say that that represent the Town but unless they have something on Selectboard Letterhead or Good Energy Letterhead, they are no represented by the Town of Dartmouth.

The Board would like the residents to be aware that the Dartmouth Water Department does not send water bottles to our residents to send samples in to check the water. This is a private company that is trying to sell water filters.
