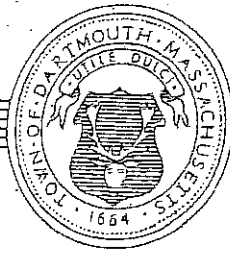

The Town Administrator called the public meeting to order at 10:00 a.m. on **January 22, 2015** in Room 301.

ISSUE I: Review Suggestions from CBI:

- The completed cost estimate was presented for this project from Steve Watchorn at CBI Consulting Inc. at last week's meeting.
- It has been decided to leave some things out of the cost estimate that will be separately funded.
- The demolition is included in this cost estimate but if hazardous materials need to be tested that will be a separate cost.
- The Department Heads have presented this information to their Boards
- *Conservation Commissioners* are on board with the plan.
- *Board of Health Members* feel the objectives have been met the best possible way with the limitations given.
- *Zoning Board of Appeals* have not been directly spoken to by Jackie Figueiredo but she feels the plan will be met with approval.
- *Planning Board* has submitted a two page list of questions that have been answered by our Board as well as Steve Watchorn. The answers have been documented by the Planning Director, John Hansen.
- Deborah drafted a document explaining the proposed Realignment of Land Use/Development Services Functions, to be read at the next Public Meeting of the Board of Selectman. After discussion the Board agreed on some minor changes.
