The February 2, 2009 meeting of the Deep River Fire Commission began at 7:07 P.M. with Spitzschuh, Berardis, Budney, and Woodcock in attendance. Kollmer was absent. Fire Marshal Nolin was also present.

The January 2009 minutes were read by Berardis. Minutes were approved as written, moved by Woodcock, 2nd Berardis. Unan.

Financial Statements were reviewed. Miscellaneous Building Supplies will be close. There is a concern with Vehicle Maintenance. There was a repair done to the pick-up, which will be approximately \$500.00. No end of year maintenance has been done to any of the vehicles yet.

5-9 and 5-7-1 were in an accident, which will be considered two separate incidents, with 1,000.00 deductibles on each truck.

Budney suggested that representatives from the Fire Commission attend budget workshops so they could explain why the Commission requests the money they do. All other bills were normal.

Chief reports 25 calls last month.

The ladder truck is coming along nicely.

There is no word on 5-9. The bumper is off the ladder truck.

New Rescue Truck chassis was delivered on Friday. Work should start soon.

Department did not acquire Durham's tanker.

Chief and B. Raymond met with Smith to discuss the Stimulus checks. Smith sent a letter to the Governor about the expansion on Headquarters. An answer should come in March. Smith also met with Joe Courtney the same morning and relayed the same information to him. The Department is also looking for money for the diesel fuel exhaust system. A new list is out to tell who the money was delegated to, but the Chief has not checked the list yet.

Department is holding off on two repeaters because changes have been made to the programming, and any difficulties should be documented.

An Energy Audit has been conducted on both Stations. At this time, the Commission feels they should sit on the information before bringing it to the Board of Finance.

Deputy attended a Valley Shore Communication meeting and reports there will be a slight increase for yearly dispatching.

Department held their yearly elections and the Commission voted to accept Woodcock as Chief, and Budney as Deputy Chief. Unan.

The Commission also voted Spitzschuh as Chairman of the Commission. Moved by Woodcock, 2nd Berardis. Unan.

Kollmer was elected as Commission Secretary. Moved by Berardis, 2nd by Budney. Unan.

Fire Marshal submitted Activity Report, Bills.

There were 25 calls last month.

Fire Marshal gave the Chief copies of forms for records disposal and explained who to send the forms to, and what the Department is obligated to hold.

There was no Chairman's report.

Budney said Tommy Lee was doing a great job filling in for the Engineer.

There was no Old Business.

Under Other Business, the Chief told the Commission this year's banquet would be held at the River House on Friday March 20th.
