The June 1, 2009 minutes were reviewed. Accepted as written. Moved Woodcock, 2nd, Berardis. Unan.

The Financial Statements were reviewed. All of last year's money has been spent. There is still money to cover other bills for last year, which have not been received yet. There is an increase to operating expenses for this year.
All other bills were normal.

Chief reported were fifteen calls last month. None were major.

A Junior went to the Cadet Program and liked it. There are now three more Juniors attending the class and the Chief will attend the graduating ceremony this Friday.

The new truck went to a show in Springfield. They also went through the truck with a checklist. He will follow up with the Company this Wednesday. It should arrive in Deep River somewhere around July 17th to 24th.

The Grant is due this Friday. It is currently 60% completed.

Deputy showed the Commission trophies won at the Field Day.
The CDL test will be held on August 22nd.

Fire Marshal submitted Activity Report, Bills.

There was a discussion on solar panels and the Commission will send a letter to the appropriate Boards to see if they could be informed when these go up. In the event of a fire, they will need different handling to control.

He also submitted a map for Incarnation.

He will be conducting an inspection at Mt. St. John this Friday at 1:30P.M. The Chief will accompany him. They should be given floor plans and keys at the time.


