The September 14, 2009 meeting of the Deep River Fire Commission began at 7:00 P.M. with Spitzschuh, Berardis, Budney, and Woodcock, and Kollmer in attendance. Fire Marshal Nolin, member T. Law, and Engineer White were also present.

The August 3, 2009 minutes were reviewed. Accepted as written. Moved Woodcock, 2nd, Kollmer. Unan.

There were no Financial statements.
No bills were available.

Chief reported 19 calls last month.

There were a few significant calls last month. A marine call to aid Chester. Fire at Tinnerello's transfer station, and car fire the previous night.

The Rescue truck is in Rhode Island to have some problems addressed. Chief asked to have it back in Deep River before Family Day on Saturday. There was a discussion on how to handle these problems after the truck has been paid for. Chief also said there have been several problems with the purchase of this truck since the beginning.

Chief checked Internet on any word on the construction grant. No money at this time has been granted to any Connecticut entrant. All money should be allocated by the first of next year.

Chief added the Tanker went to First Line for service. It will need new brakes and other maintenance. The Committee should get together to determine how to go about getting the repairs done.

AQ letter will go out to the Board of Selectmen asking for money to purchase, repair, and equip this vehicle.

Fire Marshal submitted bills, Activity Report.

Chief gave update in the Water Company's work on the sprinkler system at the elementary school.

He also noted that the KNOX box was installed at Cumberland Farms.


There was no Engineer's report.
