The February 1, 2010 meeting of the Deep River Fire Commission began at 7:08 P.M. with Spitzschuh, Budney, and Bearardis in attendance. Kollmer was absent. Woodcock was excused.

The January 4, 2009 minutes were reviewed. Accepted as written by Berardis. 2<sup>nd</sup>, Budney. Unan.

Financial statements were reviewed. Budney gave budget worksheets to all Commissioners in attendance. They were reviewed and will be submitted with a zero increase.

The fold-a-tank was taken out of waters holes and put into maintenance of the tanker. All other bills were normal.

There was no Chief's report.

The Deputy reported on a good Valley Shore Communication meeting and reports their bill should go down this coming year.

There were 17 calls last month. There was a major incident on Main Street and Life Star was called.

There was a water emergency at DRES on Jan. 31<sup>st</sup>.

There siren at Winthrop Station is broke, but a generous donator will be replacing/fixing that siren. The siren at Headquarters may also need to be replaced/repared.

The boiler at Headquarters was been fixed for the cost of #470.00. There was no labor charge.

All the same officers were elected at the Fire Department meeting. The Commission moved to accept the elections of the Fire Department with Woodcock and Budney still serving on the Commission. Fire Commission elections will be held off until more Commissioners are available for voting.

The gift certificate for Jerry Clark was been sent.

Fire Marshal submitted written Activity Report. He also handed out yearly pie charts for all calls for last year.

There was no Engineer's report. However, Deputy fielded some concerns about the new radio system which is not compatible with the equipment in place. He, as well as T. Lee, are working with the company to correct this error.

There was no Chairman's report.

Berardis asked what was the next step in looking for funding for the Plan II addition to Headquarters. There was some discussion on this matter, but nothing solid.

There was no Other business.


