April 6, 2010

The April 5, 2010 meeting of the Deep River Fire Commission began at 6:58 P.M. with Spitzschuh, Budney, Kollmer, and Woodcock in attendance. Berardis was excused. Fire Marshal Nolin was also there.

The March 1, 2010 minutes were reviewed. An addition to the two trucks which had some interest on them should be 551. The minutes were accepted with the addition. Moved by Woodcock, 2<sup>nd</sup>, Kollmer. Unan.

Financial statements were reviewed. The Chief said there was one large bill for a pump at Winthrop Station.

Deputy reports that Miscellaneous Building Supply is used up for this budget year. Vehicle Maintenance looks okay, but there will be some big expenses coming up. Communications should also go up. Training is good.

Chief reports the Banquet went well.

The tanker is at Atwood's. The cab has been painted and door gaskets were ordered. The interest on 551 fell through. There are no other interests at this time. A member is looking into giving the truck to a Fire Academy and in exchange, the Department would receive training up to the value of the truck. More information will be gathered.

There were 19 calls last month.

Essex came to help with pumping during the flooding. Budney will bring refreshments to their Rescue Jack training class to thank them for their help.

Pumps were purchased from Essex Winnelson.

Engineer is back.

5 mobile UHF radios were purchased, and will be here soon.

5 sets of gear are out for deep cleaning.

The Deputy reports Rescue Jack class in Essex will be 4/17 & 18.

Two members were at the Fire Academy. One needed assistance and went for medical attention.

Hose testing will be done in June.

Fire Marshal submitted bills, Activity Report.

He filed two letters following up on complaints from townsmen.

Walgreen's asked about selling propane tanks. Fire Marshal looked into this and finds the plans in order, but suggested that Walgreen's go to Zoning with this request.

There was no Engineer's report.

There was no Chairman's report. However he asked about the plan for the addition to Headquarters. There was a discussion on when to ask neighbors to visit and get their comments. Also when it would go up for Town hearings and referendums. The Chief commented that recent conversations with town people seemed positive.

There was no Old Business.

Meeting adjourned at 7:30, moved by Kollmer, 2<sup>nd</sup>, Budney. Unan.
