The May 3, 2010 meeting of the Deep River Fire Commission began at 7:00 P.M. with Spitzschuh, Budney, Kollmer, Berardis, and Woodcock in attendance. Fire Marshal Nolin and member B. Raymond were also there.

The April 5, 2010 minutes were reviewed. Minutes were accepted as written. Moved by Kollmer. 2<sup>nd</sup> by Woodcock. Unan.

Financial statements were reviewed. The budget looks close but should be alright. Miscellaneous will be exhausted. Communications are okay. There was a bill from the Cleaners for five sets of gear for about \$200.00. Under Operating, hose testing will be done next month. All other bills were normal.

Chief reports 21 calls last month.

A hearing on the new addition plans was discussed at a recent Selects/Board of Finance meeting. Nothing was voted on at that meeting but should come up for vote at the 5/25/10 meeting and Commissioners were encouraged to attend that meeting. A referendum should come up in June.

The Tanker is back.

ISO was here a week ago and meet with the Chief and Engineer. The Chief does not know how they stand after that meeting.

551, Pumper is at Winthrop Station and has had no activity or interest on it in the last month or so. The Department is now considering giving it to Willimantic Fire Academy in trade for training up to the value of the Truck. Before this can happen, it must be approved by the Town.

One Junior is enrolled for the Fire Academy.

Anyone wanting to support the Fire Department is asked to join on May 15<sup>th</sup>'s Beef Dinner, to raise money for the Tanker.

The Deputy reports brushes from Shipman's have been returned, but no credit has showed up in the budget. He will ask Town Hall if this ever came through.

Fire Marshal submitted bills, Activity Report.

He asked if Deep River Fire Department was going to cover the Thomas the Tank Train event in Essex this weekend. It is a Tent Event and needs coverage by Fire Officials.
