The July 12, 2010 meeting of the Deep River Fire Commission began at 7:00 P.M. with Spitzschuh, Budney, Kollmer, Berardis, and Woodcock in attendance. Fire Marshal Nolin was also there.

The June 7, 2010 minutes were reviewed. Minutes were accepted as written. Moved by Budney. 2nd by Kollmer. Unan.

Financial statements were reviewed. The Commission was very close. If the Commission is allowed to use money from the Physical account, it may stay within in budget.

All other bills were normal.

Chief reported 18 calls.

At a drill, it was noticed the Tanker had an eroded pipe. They will send it to First Line for an estimate. There was also a letter from the Academy accepting the Tanker in lieu of training equal the value of the truck. The Town approved of this sale.

One Junior graduated from the Academy.

There will be a vote on the Fire Headquarter expansion on July 13th. All members have been out trying to get their neighbors to vote.

The house next to Headquarters is vacant. Trustees are discussing how to go about utilities for that building.

Fire Marshal submitted bills, Activity Report. Activity Report showed 19 calls.

There will be a Tent Event on August 21st. So far there have been no papers provided telling the contents of the tent and flammable instructions. This tent can not go up without the instructions.

There is some discrepancy to the building 415 River Road. The property is all within Deep River, but the owner wants it to be Essex. Valley Shore has been contacted about this situation.


FIRE MARSHAL ACTIVITY REPORT JUNE/2010
