The transfer of an item from Communications has not yet been transferred to Equipment. Spitzschuh will look into this.

All bills were normal.

Chief reported 17 calls last month.

He met with the Water Company on Winter Ave. There will be a new 8" main on that street and will also include a new hydrant. This work will need to be completed by June 30th.

There are missing tarps after a mutual aid call to Chester.

The rear lights on the Tanker are "flaky." Whelen's will help with this problem as well as a citizen donating his time to make these repairs.

Memorial Day is coming up, as well as fundraisers, such as an Auxiliary event and a Beef diner.

The Lime Sale went well.

The Deputy reports there is some digging going on across from the Transfer Station and would like to ask the owners of that property if a stand pipe could be placed there during the during this digging. A letter will go out to the homeowners with this request.

The Truck Committee will now focus on a new used ladder truck due to extensive rust on the current truck instead of replacing truck 3. They will tell Town Officials of their intent.

Two new members were placed on the Building Committee.

Fire Marshal submitted bills, Activity Report.

There was a discussion on a student following him and the student's behavior. The Fire Marshal will speak to that student.

Haynes will start blasting soon.

There are two tent events coming up, which will need to be overseen by the Fire Department.

Tent codes were given to the Deputy.

He also handed communications from CNG describing how to handle natural gas, which is different from propane. He also said, CNG offers training for this.
