The April 2, 2012 meeting of the Deep River Fire Commission began at 7:02\0 P.M. with Budney, Berardis, Lee, and Spitzschuh, and Bowman attendance. Fire Marshal Nolin was also present.

The March 5, 2012 minutes were reviewed. The minutes carried as written. Unan.

A little time was put aside to upate Commissioner Bowman on some of the projects currently in progress.

The Financial Statements were reviewed. Communications was okay. Misc. Bldg, also all right. Training is close, but a grant to pay for Juniors to go to school has evened out hath line. Water holes are also okay.

There is a voucher ready to go out when the bill for the Banquet comes in.

Other bills were normal.

The Chief reports tem calls last month.

Bids went out late for the work to be done on the brush truck. Three parties were interested on the job, and it was approved to go to the lowest bidder. A detailed bill will be submitted. Delivery for these services will be five to six weeks from the start. Chief met with Smith about the Police SUV. He would like a letter explaining why the Fire Department needs these vehicles. Berardis will submit those letters to the Commission next month before forwarding them to the Selectman. The Chief will also prepare an SOG on the use of these vehicles.

Large valves for 554 have been located, but in order to put them on the truck, labor will need to be paid.

Lime Sale is 4/7/12.

Benefit for Bill Morris is 4/28/12.

Deputy reported to Bowman about the Building Project, and asked if he could help. A final report will be available to discuss at the May Meeting.

There is also a Radio committee looking to update the radio system, in conjunction with the Ambulance. They are hoping to get some grant monr=ey to offset this expense.

There will be a meeting about this next week.

There was no Engineer's report.


Fire Marshal submitted Activity Report, bills.

FIRE MARSHAL ACTIVITY REPORT MARCH/2012


