The March 4, 2013 meeting of the Deep River Fire Commission began at 7:00 P.M. with Spitzschuh, Bowden, Lanouette, Lee, and Budney in attendance. Fire Marshal Nolin was also present.

There was no meeting in February. The January 7, 2013 minutes were reviewed. The minutes were accepted as written. Moved by Lee, Unan.

The Financial Statements were reviewed. The budget has been exhausted for Training. However, the Commission was told not to worry about any money for this line. A letter will go out about this to the Board of Selectmen. Snow plowing has been more of an expense this season too. All other bills were normal.

The Chief handed out guidelines for Resolution Establishing Fire Department. The Truck Committee went to PA to inspect the new truck. The truck will be going to Alabama shortly to have the rest of the truck worked on.

There were 15 calls in January.

There were 12 calls in February.

There was a lengthy discussion on the budget. Non Recurring Capital expenditures, as well as 5 year capital plan.

Chief also asked if anyone would be willing to take over some of his clerical duties.

The Deputy reported an accident where a member was sent to the clinic, and said an incident report was forwarded to the proper Department.

There was no Engineer's report.

At this time the Commission voted on new appointments for the year.

Lee and Budney were accepted as Chief and Deputy for the Fire Department. Moved by Spitzschuh, 2<sup>nd</sup>, Bowden. Unan.

Spitzschuh remains Chairman. And Bowden as secretary. Moved by Budney, 2<sup>nd</sup> Lanouette. Unan.

Fire Marshal submitted Activity Report, bills.

There was no Chairman's report.

Other Business consisted of a note and a gift certificate from a homeowner, as a thank you, who needed assistance opening their road after the blizzard.

There was no Old Business.
