The April 1, 2013 meeting of the Deep River Fire Commission began at 7:00 P.M. with Spitzschuh, Bowden, Lanouette (left early), Lee, and Budney in attendance. Fire Marshal Nolin was also present.

The minutes of April 1, 2013 were reviewed. They accepted as written. Moved by Budney, 2nd Bowden. Unan.

The Financial Statements were reviewed. The Commission would like to borrow money from the Water Hole budget to use for in another line, if the Water Hole Committee does not need it this budget year. All other bills were normal.

The Chief reported 13 calls.

The Expedition is 98% done. Work was billed directly to the Town.

The new Ladder Truck is at the body shop in Alabama. Pictures of the truck were received last Friday.

The old Ladder Truck needs to be sold. He will speak to the Truck Committee to expedite the sale of this truck, so when the new one arrives, it can go right into that space. Delivery of the new truck is still June.

There was a discussion about the work being done across from the dump. Spitzschuh will speak to the owners of the property to see if the Fire Department can put a standpipe in.

There were a few ideas about the new building that came up. They were past onto the Board of Selectmen. Lee met with the Board and the Architect with the concerns. There will need to be more money allocated from the Board for the Architect. The Design Advisory Committee has some concerns about the size of the site to the size of the proposed building. There will be a meeting this Thursday, May 9th, at 7:00P.M., at Town Hall to discuss this further. All Commissions members were invited to attend this meeting.

There was also a lengthy discussion about CONN OSHA. Someone will discuss with the Selectman, the possibility of having someone at Town Hall to assume duties of organizing and maintaining documents needed to satisfy CONN OSHA. Headquarters is in need of a newer phone system. They will replace the old phone system and take the money for this project from the Operating line.

The Deputy reports during annual maintenance, Engineer White had concerns about the radiator on #3. Can this work be done if there is any extra money at the end of the budget?

There was no Engineer's report.

Fire Marshal submitted Activity Report, bills.

He extended his Thanks to go to department members for their cooperation after a suspicious fire last Friday.

There was no Chairman's report.

Spitzschuh asked if the house next door was to be rented. It seems he may know someone interested in renting the home.

Other Business consisted of Bowden asking if marketing for the new building could be made available for the Town's people. Different ideas were discussed, including maybe doing something on the Public Access channel. Or, maybe a slide show running during the up coming Roast Beef Dinner.

There was no Old Business.
